FLY FORBO AWARD 2021 / 2022



COMPETITION TERMS & CONDITIONS

- 1. The Fly Forbo Award ("the Competition") is run by Forbo Flooring UK Ltd ("Forbo"). The promoter of the Competition is Forbo Flooring UK Limited ("Forbo") of High Holborn Road, Ripley, Derbyshire DE5 3NT
- 2. Entry is free and open to Architects, Interior Designers and Flooring Contractors from the UK and Ireland. Applicants can enter the Competition by filling out the online entry form. Applicants are to notify Forbo of the use of the Forbo products as outlined in clause 4, in these terms, to be eligible for the Competition. Forbo reserves the right to request proof of occupation. No responsibility can be accepted for entries lost, damaged or delayed in the post, or due to computer error in transit.
- 3. The winner will be determined by Forbo's judging panel and will be the project that exhibits the most stylish & standout use of 'Forbo products' in any of the following categories. Retail, offices, public, education, hospitality, leisure, healthcare, aged care, wellbeing and environmentally sustainable design.
- 4. The Competition is only open to projects which use at least one of the following products from the Forbo commercial ranges: Marmoleum, Furniture Linoleum, Bulletin Board, Eternal, Allura, Step, Sarlon, Colorex, Flotex, Coral, Tessera, Nuway, HemingwayDesign, Sphera and Modul'up.
 - Projects using only Forbo's domestic cushioned vinyl ranges are not eligible for the Competition.
- 5. All entrants agree to grant their full permission to Forbo, or its authorised representatives and agents, to use existing images and to commission photography and on-site filming of Competition projects and allow Forbo to use such photographs and film footage in any Forbo promotional materials and publications including but not limited to use on Forbo's social media platforms.
- 6. All entrants warrant the projects submitted are their own or are submitted with the permission of 3rd party owners and does not or will not infringe the intellectual property rights of any 3rd party and further all entrants agree to fully indemnify Forbo against any loss or damages it may suffer or against any claims made against it by any 3rd party alleging a project infringes that 3rd party's intellectual property. Forbo is entitled to request proof of intellectual property rights at any time.
- 7. Entries to The Competition will close on Thursday 31st March 2022 at 5pm. Entries received after this date will not be accepted.
- 8. Judging for the Competition will take place in April 2022 with the decision of the Forbo Judges being final and no correspondence will be entered into.
- 9. The winner will be announced in May 2022 and will be advised in writing by Forbo and posted on the Forbo website www.forbo-flooring.co.uk along with images / feature of the winning project. Reasonable attempts will be made to contact the winner. If the winner cannot be contacted, or otherwise does not comply with these Terms and Conditions, or fails to accept their prize by 30th June 2022 Forbo reserves the right to offer the prize to the runner up as selected by the same judges.
- 10. Two prizes will be awarded.

The Overall Winner's Prize, subject to Prize Conditions, consists of:

- 2 x economy return airfares from UK to New York;
- Pre booked accommodation on a room only basis;
- 2 x entries to ICFF 2022 or other such design show as Forbo in its absolute discretion decides;
- \bullet £500 travel allowance (for miscellaneous expenses). Total prize value up to £6,500.

The Highly Commended Prize, subject to Prize Conditions, consists of:

- 2 x economy return airfares from UK to Amsterdam;
- Pre booked accommodation on a room only basis;
- Guided tour of Forbo's factories near Amsterdam;
- £300 travel allowance (for miscellaneous expenses). Total prize value up to £1,500.

Any reference throughout these terms and conditions to the Prize refer to this clause.

PRIZE CONDITIONS

- 1. Only one person can be awarded the Prize and should multiple individuals be named as designers or owners of the winning project the Prize will be awarded to the named applicant on the approved entry form or the relevant company director.

- 3. If the winner of either the Overall prize or the Highly Commended prize wishes to attend a show other than those listed at another location, they are entitled to request an alternative which Forbo may approve at its absolute discretion. If an alternative show is requested and approved the maximum amount that Forbo will contribute to attendance at the alternative show by way of flights, accommodation and show tickets is as follows; Overall Winner; £6000 plus cash prize; and Highly Commended prize £1200 plus cash prize. If the venue selected by the winner and approved by Forbo costs more than the amounts set out above, Forbo shall be entitled to reduce the cash prize and the winner may be required to contribute to the costs. The winner must provide Forbo with at least two months' notice of their intention to attend an alternative show failure to do so will result in the request being rejected.

- 5. All flights and accommodation shall be booked by Forbo and shall be done through airlines and hotels of its choice.

- 7. Once all air fares and accommodation is booked, the winner will not be able to alter or re-schedule the trip.
