

COMPETITION TERMS & CONDITIONS

1. The Forbo Escapes Award ("the Competition") is run by Forbo Flooring UK Ltd ("Forbo"). The promoter of the Competition is Forbo Flooring UK Limited ("Forbo") of High Holborn Road, Ripley, Derbyshire DE5 3NT
2. Entry is free and open to Architects and Interior Designers from the UK and Ireland. Applicants can enter the Competition by filling out the online entry form. Applicants are to notify Forbo of the use of the Forbo products as outlined in clause 4, in these terms, to be eligible for the Competition. Forbo reserves the right to request proof of occupation. No responsibility can be accepted for entries lost, damaged or delayed in the post, or due to computer error in transit.
3. The winner will be determined by Forbo's judging panel and will be the project that exhibits the most stylish & standout use of 'Forbo products' in any of the following categories. Retail, offices, public, education, hospitality, leisure, healthcare, aged care, wellbeing and environmentally sustainable design.
4. The Competition is only open to projects which use at least one of the following products from the Forbo commercial ranges: Marmoleum, Furniture Linoleum, Bulletin Board, Eternal, Allura, Step, Sarlon, Colorex, Flotex, Coral, Tessera, Nuway, HemingwayDesign, Sphera and Modul'up. Projects using only Forbo's domestic cushioned vinyl ranges are not eligible for the Competition.
5. **All entrants agree to grant their full permission to Forbo, or its authorised representatives and agents, to use existing images and to commission photography and on-site filming of Competition projects and allow Forbo to use such photographs and film footage in any Forbo promotional materials and publications including but not limited to use on Forbo's social media platforms. Prize Winners will be required to participate in an interview with Forbo in relation to their entry and agree to provide to Forbo high resolution images of their trip and grant permission to Forbo to use such photographs and film footage in any Forbo promotional materials and publications including but not limited to use on Forbo's social media platforms.**

All entrants warrant the projects submitted are their own or are submitted with the permission of 3rd party owners and does not or will not infringe the intellectual property rights of any 3rd party and further all entrants agree to fully indemnify Forbo against any loss or damages it may suffer or against any claims made against it by any 3rd party alleging a project infringes that 3rd party's intellectual property.
7. Entries to The Competition will close on 31st March 2023 at 5pm. Entries received after this date will not be accepted.
8. Judging for the Competition will take place in April 2023 with the decision of the Forbo Judges being final and no correspondence will be entered into.
9. The winner will be announced in May 2023 and will be advised in writing by Forbo and posted on the Forbo website www.forbo-flooring.co.uk along with images/feature of the winning project. Reasonable attempts will be made to contact the winner. If the winner cannot be contacted, or otherwise does not comply with these Terms and Conditions, or fails to accept their prize by 31st May 2023 Forbo reserves the right to offer the prize to the runner up as selected by the same judges.
10. Two prizes will be awarded.
The Overall Winner's Prize, subject to Prize Conditions, consists of:
 - Up to £6000 to be spent on the vacation or staycation of the winners dreams to include travel costs (class to be determined by reference to choice of destination) and accommodation pre-booked on a room only basis.
 - £500 cash allowance (for travel/miscellaneous expenses)
 - Total prize value up to £6,500**The Highly Commended Prize, subject to Prize Conditions, consists of:**
 - Up to £1200 to be spent on the vacation or staycation of the winners dreams to include travel costs (class to be determined by reference to choice of destination) and accommodation pre-booked on a room only basis.
 - £300 cash allowance (for travel/miscellaneous expenses)
 - Total prize value up to £1,500

As an alternative to the prizes set out in this clause 10 the Winner (either Overall Prize Winner or the Highly Commended Winner), in substitution for the relevant prize, shall be entitled to request that a donation is made on the Winners behalf to a registered Charity of the Winners choice to the value of the relevant prize, i.e. £6500.00 for the Overall Prize Winner or £1500.00 for the Highly Commended Prize Winner.

Any such chosen charity must also be registered with the Charity Commission and shall be subject to the approval of Forbo (acting reasonably).

Any reference throughout these terms and conditions to the Prize refer to this clause.

PRIZE CONDITIONS

1. Only one person can be awarded the Prize and should multiple individuals be named as designers or owners of the winning project the Prize will be awarded to the named applicant on the approved entry form or the relevant company director.
2. The Prize is non-transferable. Prize must be booked within 6 months of the date of notification of the award of the prize, but may be taken within 12 months. On notification of winning a prize, Forbo will be in touch with the winner to discuss their preferences for their prize and Forbo shall be responsible for making the bookings for the prize as requested by the winner(s). Once booked, responsibility for amends to the booking and any associated costs transfer to the 'winner'.
3. It is essential that all staycations and/or experiences booked meet the legal covid requirements at the time of travel. The 'winner' and 'commended' prize winners are responsible for Covid-19 compliance. Forbo are not liable for any trips being cut short or cancelled if government guidelines are not followed and are entitled to recoup the cost of any invalidated booking on this basis.

5. All accommodation choices are to be approved and booked by Forbo (including staycations and/or Experiences not featured in the Forbo Escapes 2022/2023 brochure).
6. There is no cash alternative. A less expensive staycation and/or experience can be booked, however, no cash equivalent is offered for the balance to the total value of the prize.
7. Once accommodation is booked, the winner will not be able to alter or re-schedule the trip other than as permitted in accordance with the chosen accommodations cancellation policies.
8. Forbo is not liable for any costs of cancellation nor any additional costs incurred by the winner in taking the Prize.
9. Forbo reserves the right to amend or alter the terms of competitions at any time and reject entries from entrants not entering into the spirit of the competition.
