# mop on restorer

## DESCRIPTION

This product is an ideal companion for any environmentally preferable floor care program. It meets today's need for a product that contains no zinc or other heavy metals that can be harmful to wastewater treatment systems. Regular use of this product will keep floors looking great. A special proprietary mix of acrylic polymers and surfactants will bond to the surface of the floor to create an anti-slip surface, while reducing the negative impact conventional floor care products have on our environment. The use of this product in an automatic scrubber is highly recommended, and is the most productive way to maintain your floors.

## DIRECTIONS

Remove surface dirt from the floor by sweeping up excess dirt and dust and then clean with a quality neutral pH cleaner to remove dirt and oils. Dilute 1 part of Forbo Mop on Restorer to 8 parts of unheated tap water and apply an even coat using a clean micro-fiber applicator or clean finish mop. Allow the restorer to dry thoroughly. When dry, the surface will have a hazy appearance. Buff or burnish to restore to the original gloss of the finish.

## CAUTION

EYE IRRITANT. MAY CAUSE SKIN IRRITATION WITH PROLONGED OR REPEATED CONTACT. Avoid contact with skin, eyes and clothing. Wear protective footwear when applying to floor. Avoid breathing of vapors. Use in well ventilated areas at all times. Floors are slippery when wet; keep all unauthorized persons away. Do not take internally. Wear rubber gloves when handling. Wash thoroughly with soap and water after handling. Keep out of reach of children.

## FIRST AID

EYE CONTACT: Immediately flush with water for 15 minutes. If irritation persists, seek medical attention.

SKIN CONTACT: Flush with water followed by washing with mild soap and water. Remove contaminated clothing and laundry before reuse. Seek medical attention if irritation develops.

INHALATION: Remove to fresh air. Seek medical attention if symptoms persist.

INGESTION: Call physician immediately.

DISPOSAL: Dispose of product (concentrate or diluted) by any method in accordance with local, state and federal laws. Best method is to recycle or reuse for intended purpose.
