SUBFLOOR

The subfloor needs to be clean, free of wax, oil, silicon and other residues which negatively influence the bonding power. After rough grinding, joints width are to be closed with wood-putty solution, mixed sanding dust.

INSTRUCTIONS FOR USE

Shake well before use. Apply 2 coats of forbo 882 Europrime Base equally with Eurocol Double-sided spatula or alternatively 1 coat with Eurocol micro fibre roller (75082) on the readily sanded and cleaned parquet floor.

Beech and other sensitive types of wood are never allowed to be treated with spatula but Eurocol micro fibre roller (1 coat).

Afterwards the floor is ready for applying a eurocol water-based lacquer.

Dyed or untreated cork floors. Do not apply to much lacquer in order to prevent colour changes due to the release of Tannin. Unsure constant air circulation while drying.

Avoid direct sun and excessive air draught.

NOTES

Please pay attention to the safety data sheets and technical data sheets used products and the recommendations and instructions of the parquet manufacturer.

In case of application on exotic wood, smoked oak or old parquet please apply Europrimer block plus or 865 Europrime Block.

The room climate during processing should be adjusted to the room climate later on in order to avoid shrinkage or extension of the parquet.

Check the moisture content of the wood and the wood climate!

Make sure when applying strong firing lacquers that a good priming is made with no overlapping and equal application.
