

Fly Forbo Award 2018/19

Competition Terms & Conditions

1. The Fly Forbo Award ("The Competition") is run by Forbo Flooring Systems Pty Ltd, A.C.N - 004 533 ("Forbo"), in conjunction with the Australian 2017 Interior Design Awards.

2. The Competition is a separate and independent competition to the Australian Interior Design Awards and is governed by the Competition and Conditions and the Prize Conditions ("the Terms"), which are agreed by all entrants into the Competition.

3. Entry is free and open to Architects and Interior Designers from Australia and New Zealand. Applicants can enter The Competition directly through Forbo by filling out the entry form. Applicants are to notify Forbo of the use of the Forbo products in their project, which uses complying 'Forbo products', as set out in these terms, to be eligible for The Competition.

4. The winner will be determined by Forbo's own judging panel and will be the one project that exhibits the most stylish and standout use of 'Forbo products' in any of the following categories. Retail, corporate, public, education, hospitality, healthcare, aged care, residential and environmentally sustainable design.

5. Complying 'Forbo products' are any commercial products that are part of Forbo's current range and are manufactured by the Forbo Group's flooring factories including: Marmoleum, Furniture Linoleum, Bulletin Board, Marmoleum Ohmex, Marmoleum Acoustic, Marmoleum Decibel, Eternal, Step, Smaragd, Sarlon Acoustic Vinyl, Colorex ESD, Onyx FR, Flotex, Tessera, Sphera, Allura, Westbond and Coral. Products not considered to be complying 'Forbo products' for this Competition are Forbo's domestic vinyl ranges in Novilon and Novilux flooring.

6. All entrants agree to grant their full permission to Forbo, or its authorised representatives and agents, to photograph competition projects and allow Forbo to use such photographs in any Forbo promotional materials and publications.

7. All entrants warrant the projects submitted are their own or are used with the permission of 3rd party owners and does not or will infringe the intellectual property rights of any 3rd party and further all entrants agree to fully indemnify Forbo against any loss or damages it may suffer or against any claims made against it by any 3rd party alleging a project infringes that 3rd party's intellectual property.

8. Entries to the competition will close on 28th February 2019, 5pm AEST.

9. Judging for The Competition will take place in March with the decision of the Forbo judges being final and no correspondence will be entered into.

10. The winner will be announced shortly after and will be advised in writing by Forbo and posted on the Forbo website www.forbo-flooring.com.au along with images/feature of the winning project.

The Prize, subject to Prize Conditions, consists of:

- 2 x economy return airfares from Australia to Amsterdam/London including return trip to Forbo Production/
- Accommodation pre-booked by Forbo (room only), in Amsterdam and London or other city hotels, design fair to be attended by the winner and which has been agreed to and approved by Forbo at its discretion;
- 2 x entries to 100% Design, London Design Fair ("the London Fair") or such other destination for the winner to attend another design fair to and approved by Forbo at its discretion;
- Award up to a maximum of AU\$1,500 (\$750 per person) travel allowance (for travel and food expenses. Any reference throughout these terms and conditions to the Prize refer to this clause.

Prize Conditions

1. Only one person can be awarded the Prize and should multiple individuals be named as designers or owners of the winning project the Prize will be awarded to the named applicant on the approved entry form and the relevant company directors.
2. The Prize is non-transferable.
3. If the winner wishes to attend a design fair other than the London Fair, they should notify Forbo immediately to determine which design fair they are able to attend and which will be approved by Forbo at its discretion, provided Forbo has given a minimum two (2) months notice before the opening date of any such design fair. If a minimum of two (2) months is not given to Forbo, Forbo will be under no obligation to consider the winner's request.
4. All matters concerning the Prize and arranging for the winner to attend a design fair should be addressed to Forbo Flooring Pty Ltd, 23 Ormsby Place, Wetherill Park, NSW 2164, Attention David Blakemore, Marketing Manager.
5. All flights and accommodation shall be booked by Forbo and shall be done through airlines and hotels of its choice.
6. All travel dates must be advised a minimum of two (2) months in advance of travel and approved by both Forbo and Forbo Assendelft B.V. and if deemed unsuitable by Forbo, with such determination being made in absolute discretion, must be re-scheduled.
7. A shorter trip can be booked to suit the winner, however no cash equivalent is offered if the winner elects to take fewer days than those offered in the Prize.
8. Once all air fares and accommodation is booked, the winner will not be able to alter or re-schedule the trip.
9. Forbo are not liable for any costs of cancellation nor any additional costs incurred by the winner in taking the Prize, attending Forbo Design Studios or the Design fair.
