Forbo Marmoleum Sheet is a homogeneous floor covering made from natural ingredients including linseed oil, rosin binders, wood flour, limestone, and dry pigments, which are mixed and then calendared onto a natural jute backing.

Sustainable Attributes:

Marmoleum Sheet is USDA Certified BioBased (100%), Declare Red List Free, and is free of PVC, PET, synthetic rubber, and plasticizers. Only PEFC certified wood flour is used in the manufacture of Marmoleum. Every square meter of Marmoleum Sheet is climate positive cradle to gate without offsetting, is inherently biodegradable, and is manufactured with 100% renewable energy. Marmoleum's 30+ year system service life makes it a more sustainable alternative to shorter-lived products.
