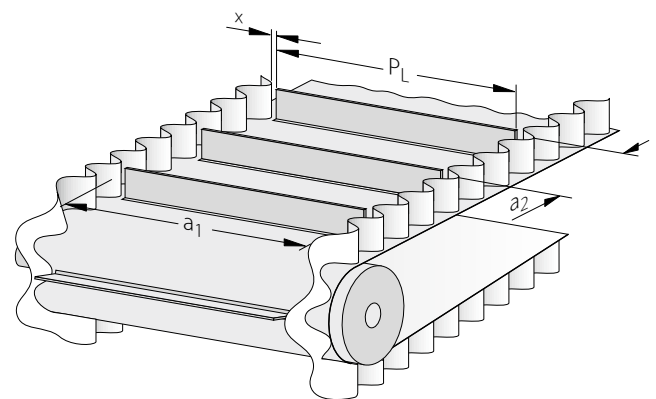

The advantages

Finished belt sizes available:

Length: 2600 to 60000 mm, Width: 200 to 1300 mm

Recommended splicing method:

Stepped overlap or stepped Z-splice

Inner distance between sidewalls:

$a_1 = 100$ to 1200 mm (for $a_1 < 150$ mm deviations in edge parallelism are possible)

Maximum profile length $P_{L\max}$: $P_{L\max} = a_1 - 2x$ (with $x = 2\frac{1}{3}$)

Sidewall amplitude tolerances: ± 1.0 mm

Manual splice tolerances:

Amplitude ± 3.0 mm; spacing distance ± 1.5 mm

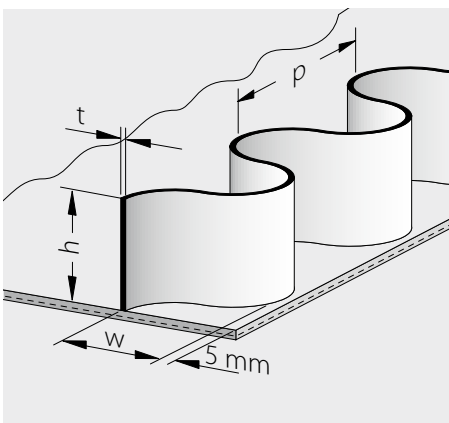

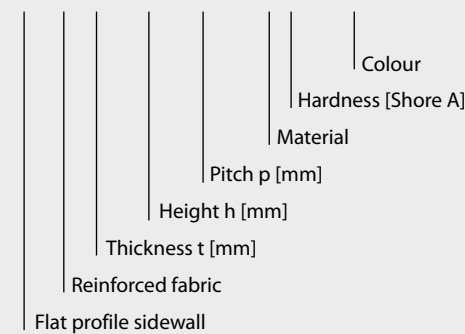
